A major focus of its assistance to enterprises is via the ROP ERDF funded <i>New Frontiers</i> Programme, which is delivered via the Higher Educational Campus incubators. MTU's Rubicon Centre Incubator manages and delivers this programme in the Cork sub-region. Enterprise Ireland works closely with the Silver SMEs project partner MTU. Good practices for policy development are being channelled to Enterprise Ireland through its close linkages with the Rubicon incubator at MTU.

Type of stakeholder	There are four Local Enterprise Organisations (LEOs) in Cork City and County. These organisations are represented by Enterprise Ireland on the ROP Managing Committee, which is convened by the Managing Authority. The LEOs are members of the Silver SMEs Steering Committee and also participate in the Steering and Review Committees for all SME development and training programmes delivered by the Rubicon Centre Incubator at MTU.

Type of stakeholder	The Rubicon Centre is the principal training and developmental resource for supporting enterprise growth in the south west region of Ireland.  As units within the MTU, both the Rubicon Centre and the Hincks Centre for Entrepreneurship Excellence work very closely together in the design of enterprise training activities. The Rubicon Centre is represented on the Silver SMEs local steering committee and participates closely on the identification of good practices from other partner regions, which can be focussed into training for the Silver Economy within the incubator's suite of courses.

#### **General Information.**

The South-West Regional Enterprise Plan to 2024 builds on the success and lessons from the previous South-West Regional Enterprise Plan to 2020. The Plan focuses specifically on enterprise growth opportunities in innovative sectors. Key areas of priority in the Plan are digitalization, sustainability, and technology.

The Regional Enterprise Plan is an initiative of the government's Department of Enterprise, Trade and Employment. The South-West Steering Committee reports to the Department on implementation via a mid-term and final progress report at end of 2024.

At regional and local levels the Regional Councils (Kerry, Cork County and Cork City) through the Local Enterprise Offices and Enterprise Ireland manage day-to-day engagements with indigenous enterprises.

The Hincks Centre for Entrepreneurship Excellence, as the MTU, research, education and policy arm providing entrepreneurship supports works with the Rubicon Centre on various activities. Accordingly, there is an established linkage in the field of SME supports between policy development, executive actions and policy review and change

Description of the Regional Policy Context	The plan builds on the earlier SWREP to 2020 and places a strong emphasis on the economic opportunities for enterprise growth, competitiveness and future sustainability. The core themes of Resilience and Recovery, Transition (Climate/Digital), Enterprise Innovation, and Regional Competitiveness are evident in each of the Strategic Objectives.
	The SWREP strategic objects include: support enterprises by strengthening the role of cluster organisations; digital enterprise and innovation hubs to support digitalisation climate action and smart working; enhance the enterprise ecosystem through innovation, entrepreneurship and digitization, agri-tech and technology development and innovation.
	The Plan is supported by the Kerry county Council, Cork
	County Council and Cork City Council and the governments Department of Enterprise, Trade and Employment.

Description of the needs to be addressed via the policy instrument	The SWREP to 2024 has a very strong focus on supporting enterprises, entrepreneurship and innovation. Part of this focus is also on new innovative opportunities for existing enterprises or new firm entrants to exploit new market opportunities.
	Much work has been completed on the identification of the global market opportunities now being presented in the Silver Economy, which is rated as the world's third largest economy. A background paper was developed by Silver SMEs partner Munster Technological University (formerly Cork Institute of Technology), with the cooperation of the Irish Central Statistics Office.
	Worldwide, by 2025, the Silver Economy is calculated to be worth over €5.7 trillion annually, making it the third largest economy ion the world. This figure is set to increase and by 2050, one in three Europeans will be over the age of 65 years. Our background paper demonstrated that the Irish population aged over 50 years currently has an annual disposable income of c. €40 trillion. Of that sum, the Southern and Eastern Region has a disposable income of €13.3 trillion and the South West shows a sum of 5.9 trillion for the same age bracket.

Actions proposed	
Action 1:	The inclusion of the silver economy as an action under the strategic objectives of the new South West Regional Enterprise Plan to 2024. (SWREP)
Inspiration for the action	It is proposed that the value of the silver economy will be included as an action under the Strategic Objective 3: Enhance the enterprise eco-system across the region through innovation, entrepreneurship and digitalisation
	Based on its developed knowledge of the growing global Silver Economy, the Hincks Centre for Entrepreneurship Excellence at MTU will engage with the policy makers and executive agencies developing the Plan to the value of including the silver economy as a new sector for new and existing enterprises can explore.





The action is inspired by the good practice presented by the Silver	
Economy Unit of the Chamber of Commerce and Industry of the	
Creuse region in France. It is also influenced by the Social	
Entrepreneurship Programme of the Aragon Region of Spain.	

In the case of Creuse, this good practice is also reflecting the experience of the Hincks Centre in its role of proximate policy maker in this field, related to developing specific training and awareness programmes for local enterprises in our own region.

The Creuse good practice shows how the region took focussed actions to highlight the strong market potential of the silver economy to local enterprises. We identify with the good practice because in Creuse the region decided to become very proactive by encouraging enterprises in its region to actively examine the potential of the silver economy and in particular encouraged enterprises to look for specific opportunities, which could be realised in the Creuse region.

The Aragon region included the topic of silver entrepreneurship within its social entrepreneurship development activities. With regional operational programme funding a number of social entrepreneurs interested in developing with in the Silver Economy are provided with training and mentoring each year.

MTU believe that a similar targeted initiative can be delivered in our region.

## Relevance to the project

The targeted SWREP to 2024 and enhanced enterprise eco-system, is supported via the provision of entrepreneurship training and mentoring supports for enterprises within the plan.

Within the Munster Technological University (MTU), the Silver SMEs project is led by MTU's Hincks Centre for Entrepreneurship Excellence. Hincks Centre supports entrepreneurship in all its forms through research, education and training.

The Hincks Centre team, as the SilverSMEs project leader in Ireland, has been inspired by and has benefited substantially from the exchange of experience and good international practices based on project activities. These activities have included study visits to witness at first hand the innovative approaches to developing the silver economy in other partner regions.

The Hincks Centre is therefore excellently placed to promote the inclusion of the silver economy in the new Plan.

Completed by mid-2022.  This action will incur limited costs and will be funded by the Hincks Centre.  This familiarisation and training on the market opportunities for regional enterprises and new start-ups in the Silver Economy.
Inspiration for the action	The action is inspired by the good practice of the project partner in the Creuse region of France and by the good practice as set out by the Aragon Region of Spain.  It is necessary to have all of the key stakeholders and policy makers on board to ensure that knowledge of the potential of the silver economy is maximised within the region's policy making bodies, local enterprise support offices.
Relevance to the project	Through the delivery of the Silver SMEs project in the Region and building on lessons of good practices throughout the project regions, our objective is to highlight to the various managing, intermediary and executive agencies involved in delivery of the SWREP to 2024, that substantial opportunities exist to create a specific sectoral focus on the opportunities presented by the Silver Economy.  We will highlight that locally, regionally, nationally and internationally- there exists a strong opportunity to foster Silver economy related growth for entrepreneurship, innovation and job creation in regional enterprises. This identification of new opportunities will have downstream impacts relating to the delivery of enterprise development and training programmes, focusing on the needs of the silver sector.  These needs relate to different cohorts such as the active over 50's to age 75 who have more significant disposable wealth and time to enjoy it; and older and more dependant Silvers who have specific health and accommodation requirements.
